- **Asset Integrity Management:** Development of Asset Integrity Management System – covering subsurface, facilities, pipelines.
- **Process Safety Management (PSM):** Conduct of process Safety Assessments at all stages of a Project (and for mature projects); Facilitation of HAZard and Operability Reviews (HAZOPs); Development of Process Safety Management Systems (independent or as part of broader Operational and/or HSE Management Systems).
- **Emergency Response:** Emergency Response Procedures for onshore Construction Yards; Emergency and HSE Interface documents for Offshore and onshore Construction Activities (SIMOPS)
- **Drilling HSE Management:** Assignment of CWI personnel to Project Teams for integrated HSE Management including development of project documentation, Contractor HSE management, Auditing
- **Project Stakeholder Management:** The identification and understanding of Stakeholders (people, organisations with an interest in the Project) and their concerns and agendas is an important part of any Companies Project Management System
- **Environmental Issues Management:** Environmental Management and an early identification and management issues should always be a major part of any Companies Project Management System.
